

Introduction

ATSPM's Arts, Science and Commerce College believes in the empowerment of women and has zero tolerance for sexual harassment. College administration feels that everyone who is working or studying in the college has the right to be treated with dignity and respect and a right to safe and healthy work environment. The college is committed to providing a place of work and study that is free of sexual harassment. Hence the college has an Internal Complaints Committee which looks promptly and thoroughly into matters related to sexual harassment. The committee will respect the confidentiality and privacy of individuals reporting and the accused of sexual harassment to the extent possible. Care will be taken to see that complainants, witnesses and the harasser does not face victimization and discrimination during the process of enquiry.

What constitutes sexual harassment?

Sexual harassment as defined in the Sexual harassment of women at workplace (prevention, prohibition and redress) Act, 2013 includes any one or more of the following 'Unwelcome' acts or behavior:

- physical contact and advances;
- a demand or request for sexual favors;
- making sexually colored remarks;
- showing pornography; or
- Any other unwelcome physical, verbal or non-verbal conduct of sexual nature.

This would also include online harassment via internet, sms and social network sites. Further, the following may also amount to sexual harassment:

- implied or explicit promise of preferential treatment;
- implied or explicit threat of detrimental treatment;
- implied or explicit threat about present or future employment status;
- interference with work or creating an intimidating or offensive or hostile work environment; or
- humiliating treatment likely to affect health or safety.

Process for Complaint and Inquiry

Step I: An aggrieved woman should give a written complaint either in person or through post or email. It should be submitted to the 'Prevention of Sexual Harassment and Atrocities against Women Committee' within 3 months of the date of the incident. The time limit may be extended for a further period of 3 months if, on account of certain circumstances, the woman was prevented from filing the complaint. If the aggrieved woman is unable to make a complaint, her legal heirs may do so.

Step II: On receipt of the complaint, the ICC will proceed to make an inquiry in accordance with the service rules or in their absence, in accordance with rules under the Act. The inquiry will be completed within 90 days. And the inquiry report will be submitted within 10 days from the date of completion of the inquiry.

Step III: If the ICC finds that the allegations against the respondent are proven, it will submit a report to the Principal to take action for sexual harassment as misconduct in accordance with the provisions of the applicable service rules or where no service rules exist, in accordance with rules framed under the Act. **Step IV:** The college management will act on the recommendations of ICC within 60 days of the submission of the inquiry report.

Step V: Appeal against the decision of the ICC is allowed within 90 days of the recommendations.

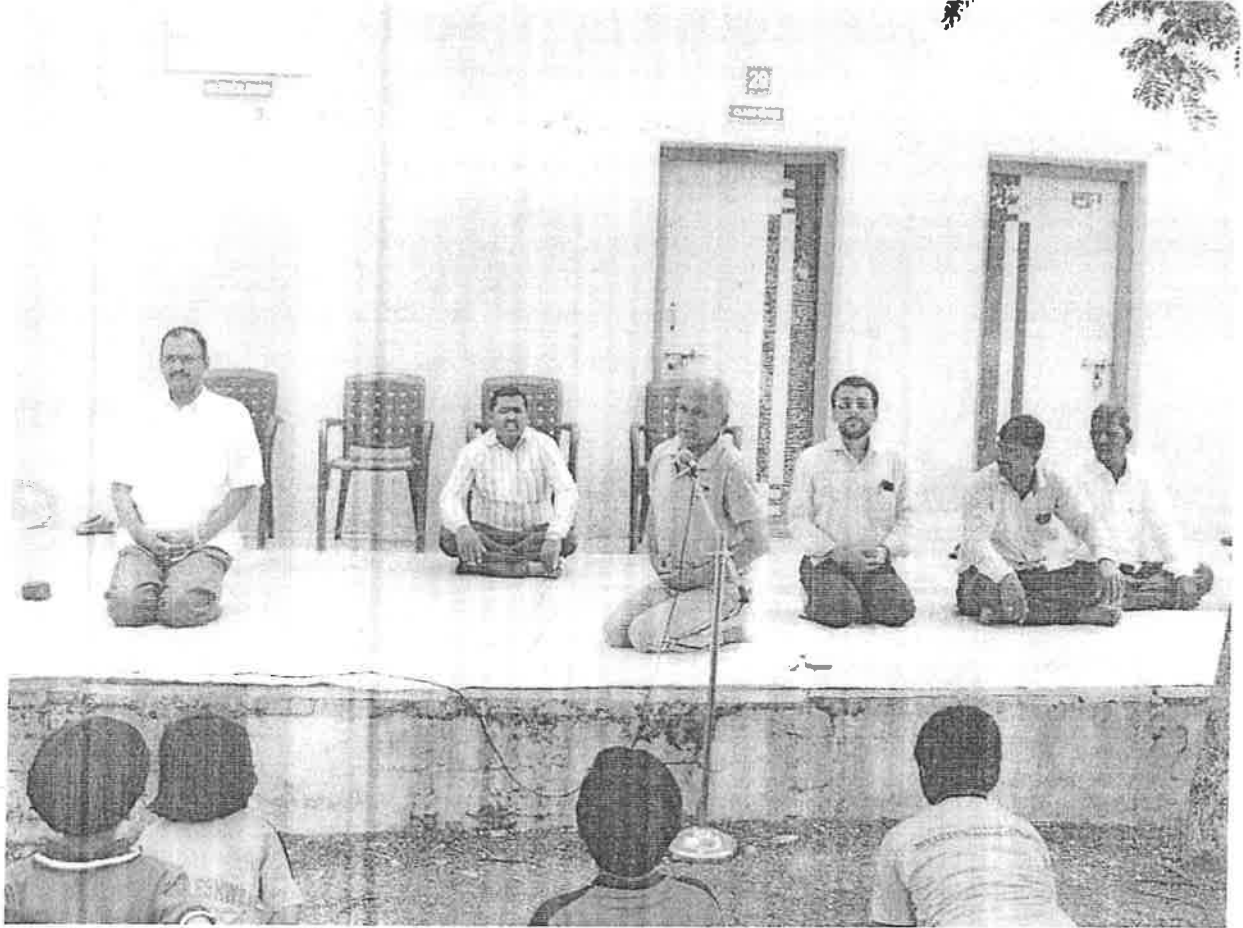

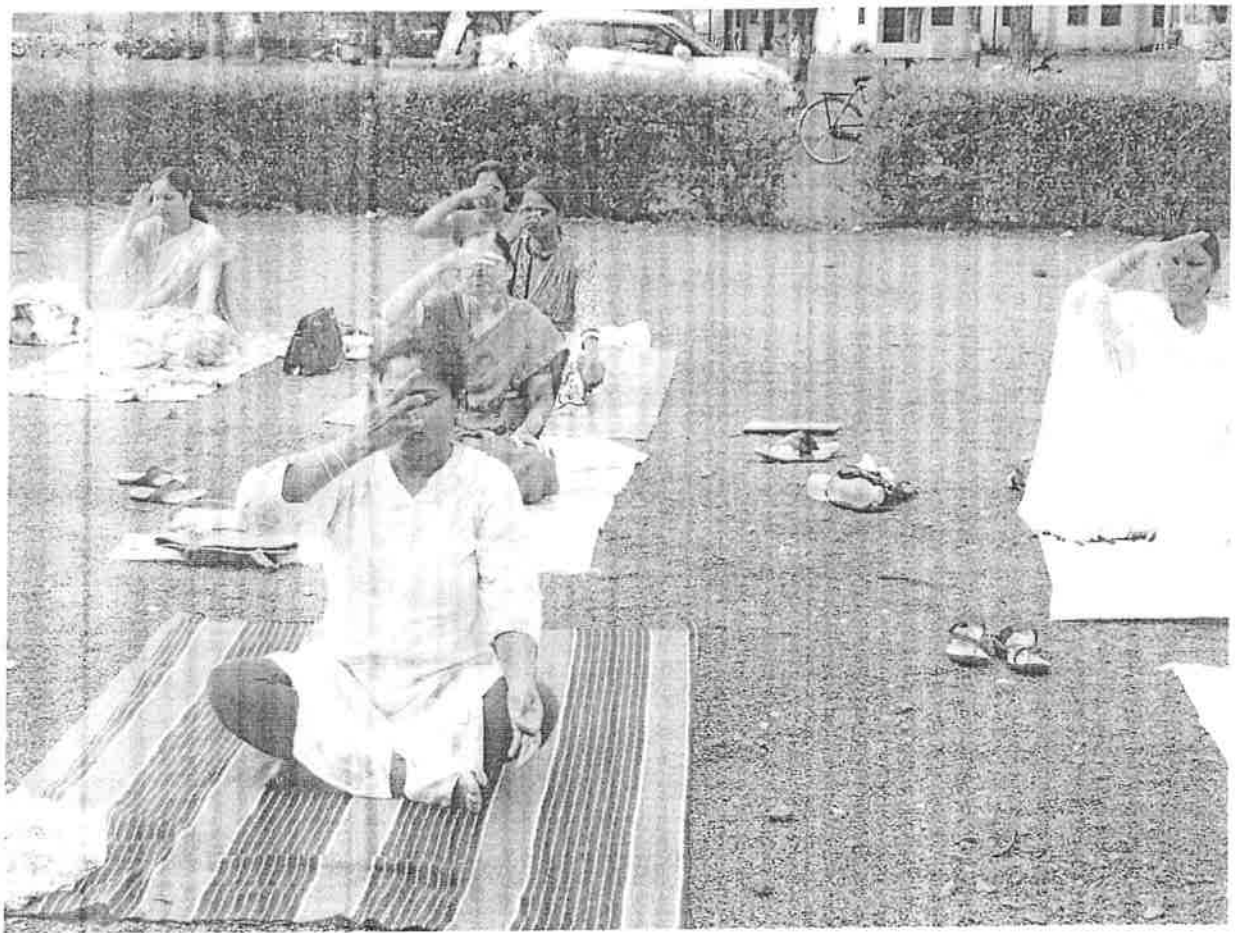

A workshop on womens law was organized in the college with joint venture of Maharashtra state women commission & A.T.S.P. mandals Arts. Comerces & Science college Ashti on dated 13/10/2018 It was Inaugarated by Hon. justice F.T.Shaikh (Ashti) at 11: am. In her speech she stressed on injustice of women in society& the laws applicable for their justice. No doubt our Indian culture is supreme but there lies difference between traditions & systems. Our culture gives us a message to wear a full uniiforms & avoid latest fashinoating cloths but women sometimes forget this messages on the same occasion D.Y. S.P. Hon .mandar Naik delievered a speech on brutel system of live in relationship he also made counseling with the girl students.

The chairperson of this inaugration function , Hon. Shri .Kishor nana Hambarde expressed the need of sisterhood brotherhood , & freedom of women. More over he says that husband & wife are the two wheels of one vehicle so they should maintained our cultural values.

The anchor of this function was Amruta ugale while the principal Dr. S.R. Nimbore .has delivered a preface speech & prof. Narote S.G. expressed the vote of thanks.

Session I st of workshop was started at 11:30 to 12:30 am in which group discussion was organized on the following issues.

- i) Sexual Harassment of women at work place.
- ii) Laws for domestic violence & difficulties faced.
- iii) Womens law –Realisation & desperation.
- iv) Indian cul ture, Laws & their set backs.

The said group discussion was devided in to 4 groups including 5 boys. 5 girls, advocate 1 police, 1 Gents teacher & 1 Women teacher. Group ,A was leaded by Ku.Aparna vaidya, B.was leaded by Ku Rutaja fartare, C was leaded by sakshi meher & D was leaded by Ku.Sole Priti .All group leaders were came to the conclusion that male dominating Mentality is responsible for sexual Harassment of women at work places & other common places. Basically they use . jesturical language & taunting for humiliation of women. They also expressed that domestic violence, comes through dowery a system sometimes men can remarry while showing cause of less dowery by their wives

Now a days the laws for children &Women are strictly regulated to protest dowery Systeam & marrieges of girls below 18 years, Of age .There is a need of sociala wareness to marginalise inequality between men & women .And for that there needs the organization of social awareness programs. Sometimes it happens in society that women are never to be taken inconsideration for familial decisions they are always treated as marginal. Exceptionally women are also responsible for imbalance and inequality in sociology equality .No doubt Indian culture is male dominating so that men can have a unwritten rule to remarry after death of first wife but the same right is different for women because the society never can easily permits the widowed women for remarriage.

Second session of the workshop was started at 12:30 p.m. & ended at 2: p.m the chiefguest of function was adv. Sou. swati yadwadkar (pune) she advised & expressed her opinion about the difficulties of women law implementation though women have legal right of self nourishment, society never accept their freedom. They haven't have their own decision making power. Which resulted into domestic violence. She also clearly focused on the problems & laws of girl child & the posco 2012 along with the tripple talak by mentioning IPC 480, in Indian culture marriage system is related to the stable family but whenever society prevails women from their freedom, atomatically marriage system & familial system collapses.

The chairperson of II nd session was hon.Principal Dr.S.R. Nimbore . in his speech he noticed that the strength of girl students in our college is remarkable because they feel secure in College campus. We have a mechanism under the guidance of few teachers to control girevences & torturing of girl students. Finally he says such workshops are helpful & fruitfull for girl students & women in society.

The anchor of this session was Ku. Amruta Ugale & Prof Smt. Kambale R.R. expressed the Vote of thanks .

After this session a lunch facility was provided to the participants.

The validictory function of this workshop was started at 3:00 pm. & the chief guest was smt. Tarkeshwari shiralkar (M.C.D C Bboom Nagar panchayt, Marathwada rigion) Mrs. shiralkar also expressed her opinion on sexual Harassment of women at workplace & advised women that they should prepare themselves for their own diffence & also asked women that they shouldl. lodge legal cases on crimal when ever nessasry .most of the women are not aware of the laws but Mrs. Bhawari devi from Rajastan has lodge the legal case against injustice & domestic violence in the court of law which resulted the existence of vishakha law in 2013 which protects women from all type of violencess.

The chair person of this session was Hon.Shri .Atulshet Meher (secretary A.T.S.P.mandal) who expressed that women should Know & realized at least few laws concern with them.

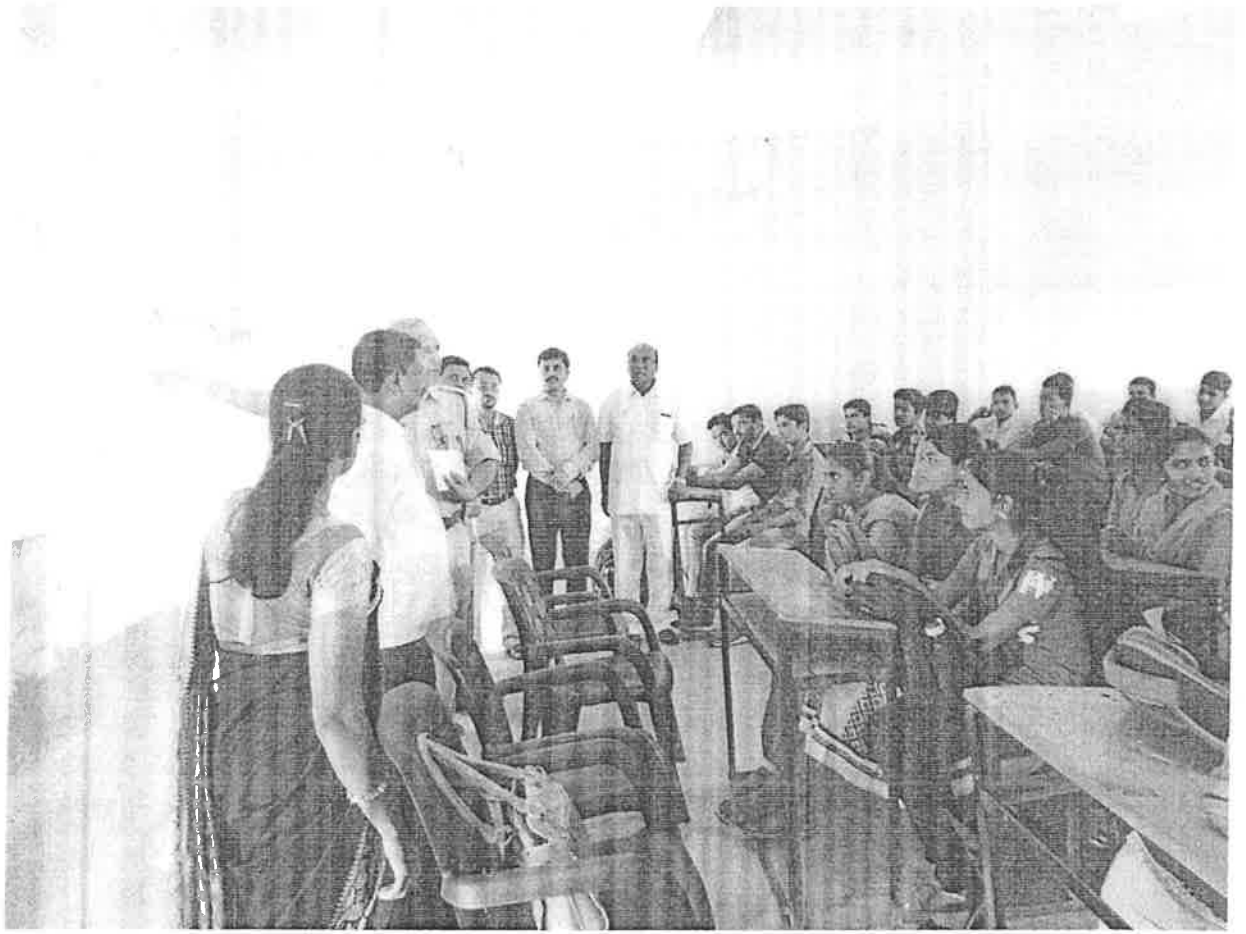

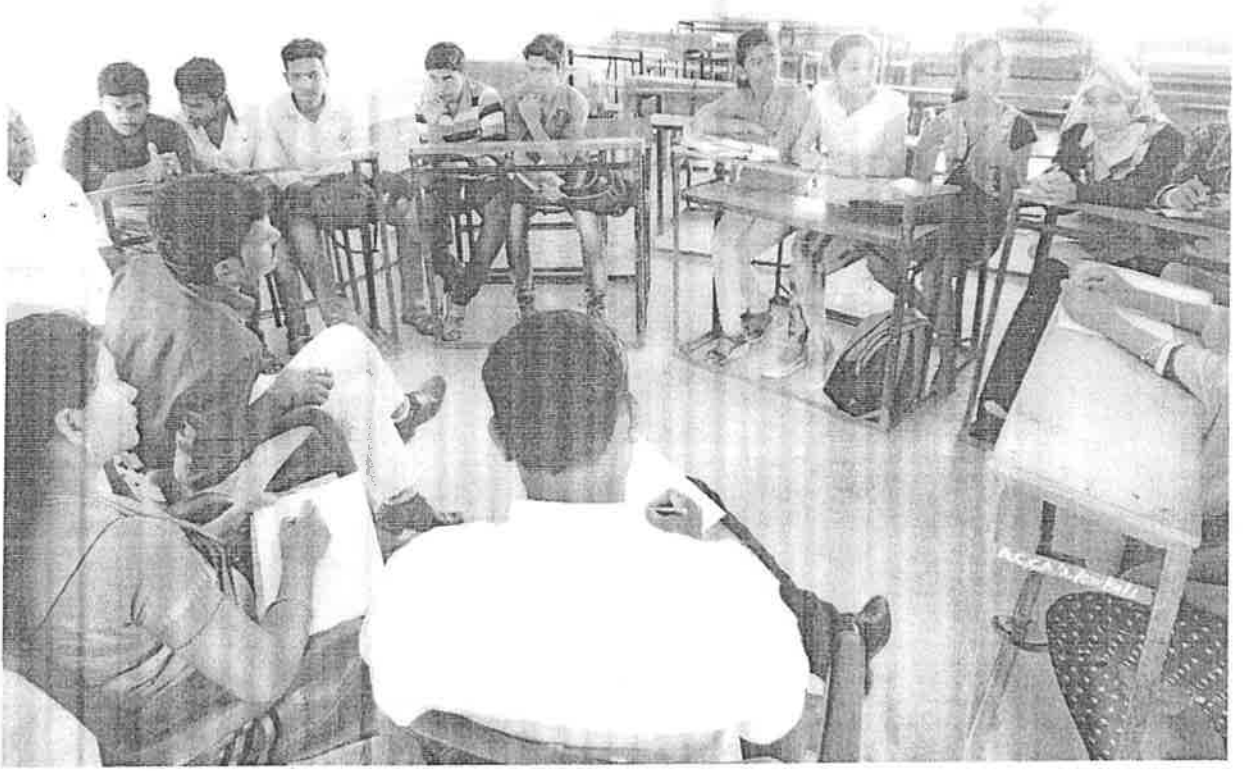

Report (Session-wise summary)

Inauguration:

Mrs. Sharda Dalvi guided the audience about the policies of government and related her own story. Hon. Kishor Hambarde in his complimentary close assured the lady parents and girl students the safety in college and promotion of women empowerment policies in college. Prin. Dr. S. R. Nimbore in his preface talked about the objectives and schedule of the two day national seminar. Prof. Mrs. Shubhangi Khude compered the sessions. Mrs. Saraswati Jadhav expresses vote of thanks.
